## DO NOT SOLICIT LIST INFORMATION

Please note that by signing the above form, you are stating that you do not desire any type of solicitation or materials to be left at your residence (charitable, religious, political, commercial, etc), except solicitors that you have affirmatively invited and/or materials that you have affirmatively requested. Solicitation - means communicating with another person without invitation for any commercial, charitable, religious, political or other purpose by means of: i) in-person contacts; or ii) distribution of written material, including the placement or delivery of such materials at the premises or on any property belonging to a third person. The Do-Not-Solicit-List will be posted online and hard copies will be made available to any person who seeks a Solicitation Permit or who requests a copy of it. Any person violating your request not to be solicited may be prosecuted as a trespasser under Chapter 5.34 of the North Aurora Municipal Code. If you are solicited in violation of Chapter 5.34 of the North Aurora Municipal Code, please keep a copy of any solicitation materials left at your residence and notify the Village Police Department at the non-emergency number of 630-897-8705. You may be asked to execute a complaint and/or to testify in court or administrative proceeding or otherwise participate in enforcement of this request signed by you. You are not obligated by signing this request to be added to the Do-Not-Solicit-List to sign a complaint or to testify, but the Village reserves the right to remove your residence from the Do-Not-Solicit-List if you choose to not participate in the enforcement of this request.

If you wish to withdraw your address after it is placed on the Do No Solicit List, you need to provide a written request to the Village stating your desire to be removed from the Do Not Solicit List. You also have the obligation to notify the Village if you move so that your address may be removed from the Do Not Solicit List. Any person at your residence has the right to place the residence on the Do Not Solicit List. If a person other than yourself has included your residence on the do Not Solicit List, you must obtain that person's consent to have the residence removed from the List. If the person(s) who requested your residence to be placed on the Do Not Solicit List no longer own or are no longer in lawful possession of the property, you may provide an affidavit to that effect if you wish the property to be removed from the List.

The Do Not Solicit List will be compiled by address and not by name. Therefore, if you move to a new address within the Village and desire that property to be included on the Do Not Solicit List, you must submit a new form with your request that the new address be added to the List.

You may also help ensure your privacy by posting a "No Solicitation" or other sign with similar language at or near your door. "No Solicitation" signs are available at the North Aurora Police Department.
