Water Distribution System Material Inventory

The Illinois Environmental Protection Agency (IEPA) created a requirement for all community water systems in the state of Illinois to develop a Water Distribution System Material Inventory and submit this inventory to them by April 2018 and continuing every April thereafter until completed. The Village is in compliance with this requirement and we are preparing to submit a more accurate inventory this April, 2020.

Over the next several months the Water Division will be contacting residents who live in homes built in the early **to mid-1970s and earlier**. If your home falls into this category please let us know as we are needing to further determine the exact material of the water service line coming into these age homes.

The Water Division is happy to perform the visual inspection of your water line and this inspection should only take a few minutes pending clear access to the water meter area in your home. Please call **630-906-7495** to make an appointment or, if you are able to determine the service line material, call to report this information.

We thank you in advance for your cooperation in this matter as we continually strive to improve North Aurora's water system. If you have any questions, please call Paul Young, Water Operations Superintendent at 630-906-7377.

Code Enforcement Reminders

• The **watering conservation ordinance** is in effect every day of the year. The ordinance allows the use of a hand held device any time. It also allows for all properties with **even-numbered street addresses** to use water for restricted watering purposes on **even-numbered days** of the month only during the hours of **6 a.m. to 9 a.m. and 6 p.m. to 9 p.m** and all properties with **odd-numbered street addresses** to use water for restricted watering purposes on **odd-numbered days** of the month only during the hours of **6 a.m. to 9 p.m.**

• Lawns must be kept under 8" in height. This includes weeds.

• Trash cans and lawn waste bags should not be placed at the curb until 3 p.m. the day before trash pickup, and such containers must be removed from the curb no later than midnight of the day of collection.

• Campers, boats or other RV's can be parked on front drives Friday noon through Monday noon only. **Exception:** campers, boats, and Rv's may be parked on the driveway during April 15 to April 30 and Oct. 1 to Oct. 15 for maintenance.

• Do not block the street or sidewalk with anything, including basketball hoops, toys, landscape materials, or poorly parked vehicles. Vehicles are not allowed to park on the grass.

Waste Management Spring Clean-Up:

Spring Clean-Up Day will be a two-day pickup, with free non-hazardous clean-up items, as well as regular trash being picked up on Friday, May 15 for all residences West of the Fox River, and Saturday, May 16 for all residences East of the Fox River. All non-hazardous bulk trash items will be picked up for free. Stickers are required for all regular garbage and yard waste, which will be picked up on the same day as the clean-up schedule. Please have all items out by 7 a.m. as route time's change for this special pick-up day.

Holiday Garbage Pick-Up

Due to the Memorial Day holiday, garbage pick-up will be provided on Saturday, May 30. There will be no garbage pickup delay for the Spring Holiday on Friday, April 10.

Yard Waste Pick-up resumes on Friday, April 3rd. Kraft paper bags and waste stickers are required for all yard waste pick-ups through the end of November. Brush and branches must be bundled in 4 ft. lengths not exceeding 50 lbs. and require a sticker at all times. Bagged leaves are picked up free only during October and November. Any leaves left from last summer will need to be bagged and will require a waste sticker.

Free Mulch is available at 316 Butterfield Road. Residents will need to load their own mulch; no delivery available.

Mailbox Condition and Yard Damage from Plows

Is your mailbox installed properly? During the winter, unstable mailboxes and decaying wood posts are more likely to be damaged from heavy snow coming off the snow plows. Spring is the best time to check that your mailbox is securely fastened and that the post is in good condition and securely set in the ground. If your mailbox was struck by a plow and damaged please contact the Public Works Department within 48 hours to allow time to inspect the mailbox to see if the Village is liable. The Village is not responsible for mailboxes damaged by snow coming off the plows. Any damage to your lawn caused by the Village's snowplows will be repaired as the weather warms and the ground thaws. Please contact the Public Works Department as soon as you identify snowplow damage.
