Sealed BIDS for the **CHERRYTREE COURT WATERMAIN** project will be received by the Village of North Aurora at the Village Hall until 10:00 A.M. (Local Time), on the 15<sup>th</sup> day of February, 2017, and then at said office and time, publicly opened and read aloud.

The proposed work to be performed under the contract consists of replacing the existing 6-inch watermain with approximately 2400 LF of new 8-inch ductile iron pipe and 160 LF of new 6-inch ductile iron pipe, CL-52; the replacement of the water services along with the appurtenances, and related restoration work at locations shown on the Plans in the Village of North Aurora.

All bidders must be IDOT pre-qualified.

All BIDS shall be submitted on the forms provided, and shall be accompanied by a Certified Check, Cashier's Check, or Bid Bond, in an amount not less than five percent (5%) of the amount of the Bid, and subject to the conditions provided in the Instructions to Bidders and Certificate of Apprenticeship Training by DOL-BAT.

The Village of North Aurora reserves the right to reject any and or all Bids, to waive any irregularities and informalities. Awards will be made to the lowest responsible Bidder as determined by the Village of North Aurora.

All applicable laws, ordinances, and the rules and regulations of all authorities having jurisdiction over construction of the Project shall apply to the contract throughout, including the Illinois Prevailing Wage Act (Ill. Rev. Stat. Ch. 48, Sects 39s-1-12) and the Illinois Preference Act (Ill. Rev. Stat. Ch. 48, Sects. 2201-2207). Federal labor standards and prevailing wage rates will apply to portions of this project. Minorities and Women Owned Businesses (MBE/WBE) are encouraged to submit bids on this Project.
