

Advertisement for Bids

The Village of North Aurora will receive sealed bids for the Elm Avenue and Maple Avenue Water Main Improvements. The sealed bids will be received at the North Aurora Village Hall, 25 East State Street, North Aurora, Illinois 60542 until 10:00 a.m. local time on Wednesday, April 8, 2020. At this time and date, the bids will be publicly opened and read aloud. The proposed improvements consist of the installation of approximately 1,373 feet of 8-inch ductile iron water main and related appurtenances including three (3) full lead water service replacements on Maple Avenue and Elm Avenue.

A mandatory pre-bid meeting for all GENERAL CONTRACTORS issuing a BID will be held at 1:00 p.m., local time, March 27, 2020 at North Aurora Village Hall, 25 East State Street, North Aurora, IL 60542.

Rev. Stat. Ch. 48, Sects 39s-1-12) and the Illinois Preference Act (Ill. Rev. Stat. Ch. 48, Sects 2201-2207).
