#### NORTH AURORA DAYS COMMITTEE MEETING MONDAY, JUNE 19, 2017

#### Call to Order

Confirmed that the Community room is reserved for packet pick-up. Robyn had the room reserved. They will get information to Brenda English for the Softball tournament – regarding forms, porta pots, etc.

Kim Haeger said they should be good for the beer tent. They would like more signage with the different costs, beverages and such. They are pretty good on volunteers. They are in need of a MC for announcements.

Robyn Stecklein stated that everything for the Safety Event at Mooseheart is set and will be working with the Kane Co Safety Coalition. Robyn and Mark Gaffino met with Mooseheart personnel and they are set for the events. They will also serve food during the safety day event.

Steve Bosco stated that we have 5 rides set up and the game truck reserved.

The next North Aurora Days meeting will be held on Monday, August 21st, 2017 at 5:30pm at the Village Hall. This will be a re-cap of the event.
