### **Scope of Project:**

*The Well No. 5 Modification work shall include, but not limited to, demolishing an existing well house including all piping, electrical, controls, and appurtenances; furnishing and installing new well discharge piping, new level transducer for well, new flowmeter, new well control panel, new precast concrete meter and valve vaults; electrical and SCADA modifications; site restoration and appurtenances.*

A **Non-Mandatory Virtual Pre-Bid Meeting** (Pre-Bid Meeting) will be held on **March 1, 2022**, at **9:00 am**. In order to attend the Pre-Bid Meeting, all prospective Bidders must pre-register by contacting Keith Powell with Engineering Enterprises, Inc ([kpowell@eeiweb.com](mailto:kpowell@eeiweb.com) or (832) 445-8631). **We strongly encourage all prospective Bidders to attend the Pre-Bid Meeting, due to pertinent discussions on scope items and project funding details.** After the Pre-Bid Meeting, all prospective Bidders will be allowed to visit the water treatment plant. **The site visit will be conducted on March 1, 2022, from 1:00 pm to 3:00 pm. This will be the only opportunity for prospective Bidders to obtain full access to the water treatment plant. During the site visit Bidders must follow the current IDPH guidelines by wearing a mask and maintaining six feet physical distance from others.**
