The Village of North Aurora will receive sealed bids for the 2022 Road Program Resurfacing Project. The sealed bids will be received at the North Aurora Village Hall, 25 East State Street, North Aurora, Illinois 60542 until 10:00 a.m. local time on Wednesday, March 16, 2022. The proposed improvements will be completed on the following streets: Aster Court, Augusta Drive, Cantigny Court, Clark Street, Coghill Court, Columbia Circle, Derby Drive, Dewig Court, Doral Lane, Fairfield Way, Greenbrier Court, Hammer Lane, Hart Road, Hartfield Drive, Matthias Court, Meadow Lane, Oak Crest Drive, Pinecreek Drive, Slaker Court, Spyglass Court, Turnberry Drive, Wingfoot Drive, Winterberry Court, and Woodlawn Drive.

The project will include the following pay items and quantities. Preparation of Base (74,548 SY), Removal and Disposal of Unsuitable Materials (3,965 CY), Aggregate Subgrade Improvement (3,965 CY), Hot-Mix Asphalt Surface Removal 4" (52,530 SY), Hot-Mix Asphalt Surface Removal 5" (35,833 SY), Hot-Mix Asphalt Binder Course, IL-19.0, N50 (13,696 TON), Hot-Mix Asphalt Surface Course, Mix "D", N50 (9,011 TON), Combination Concrete Curb and Gutter Removal and Replacement (13,624 FT), Sidewalk Removal (34,058 SF), PCC Sidewalk 5 Inch (33,653 SF), Detectable Warnings (1,500 SF), Structure Adjustments (105 EA), Inlets To Be Reconstructed (4 EA), Frames and Grates (8 EA), PCC Driveway (20 SY), HMA Driveway (1,253 SY), Brick Paver Removal And Re-Set (485 SF), Restoration (3,248 SY), Traffic Control and Protection (1 LSUM).

Each bid must be accompanied by a Bid Guarantee in the form of a Bid Bond from a company with an A-1 best rating, or a cashier's check in the amount of five percent (5%) of the total bid and made payable to the Village of North Aurora, 25 East State Street, North Aurora, Illinois, 60542. The Village of North Aurora reserves the right to reject any or all bids and to waive irregularities and informalities in the bids received.

All applicable laws, ordinances, resolutions, and the rules and regulations of all authorities having jurisdiction over construction of the Project shall apply to the contract throughout including the Illinois Prevailing Wage Act (Ill. Rev. Stat. Ch. 48, Sects 39s-1-12) and the Illinois Preference Act (Ill. Rev. Stat. Ch. 48, Sects. 2201-2207).
