



Advertisement for Bids

The Village of North Aurora will receive sealed bids for the 2023 Road Program Resurfacing Project. The sealed bids will be received at the North Aurora Village Hall, 25 East State Street, North Aurora, Illinois 60542 until 10:00 a.m. local time on Wednesday, March 29, 2023. At this time and date, the bids will be publicly opened and read aloud. All bids must be addressed as follows:

The proposed improvements will be completed on the following streets: Carpenter Court, Chesterfield Lane, Erickson Court, Flynn Court, Gorham Court, Graham Road, Hamilton Lane, Harding Court, Johnson Court, Pine Creek Drive, Schneider Court, Stewart Avenue, and Thompson Avenue.

The project will include the following pay items and quantities. Preparation of Base (49,496 SY), Hot-Mix Asphalt Surface Removal 4" (49,496 SY), Hot-Mix Asphalt Binder Course, IL-19.0, N50 (6,520 TON), Hot-Mix Asphalt Surface Course, Mix "D", N50 (5,166 TON), Combination Concrete Curb and Gutter Removal and Replacement (8,451 FT), Sidewalk Removal (21,548 SF), PCC Sidewalk 5 Inch (21,349 SF), Detectable Warnings (1,190 SF), Structure Adjustments (86 EA), HMA Driveway (1,221 SY), and Restoration (3,204 SY).

The bid packet can be downloaded, free of charge, at the Village's website <http://northaurora.org/government/rfp-rfq-bidding.aspx> or can be picked up at 25 East State Street, North Aurora, IL 60542 beginning Friday, March 10, 2023. **All bidders must be pre-qualified with the Illinois Department of Transportation to bid on this project.**

Each bid must be accompanied by a Bid Guarantee in the form of a Bid Bond from a company with an A-1 best rating, or a cashier's check in the amount of five percent (5%) of the total bid and made payable to the Village of North Aurora, 25 East State Street, North Aurora, Illinois, 60542. The Village of North Aurora reserves the right to reject any or all bids and to waive irregularities and informalities in the bids received.

All applicable laws, ordinances, resolutions, and the rules and regulations of all authorities having jurisdiction over construction of the Project shall apply to the contract throughout including the Illinois Prevailing Wage Act (Ill. Rev. Stat. Ch. 48, Sects 39s-1-12), the Illinois Preference Act (Ill. Rev. Stat. Ch. 48, Sects. 2201-2207) and an Apprenticeship Training Program certified by the USDOL.
