Jay's Wine and Liquors, 188 Butterfield Road, is changing owners. Jay's Wine and Liquors Inc. was the previous business owner and Kamla Smruti, LLC. is the new owner. The new owner is now requesting a Class D Liquor Store License. Due to the fact liquor licenses in the Village of North Aurora do not transfer, the Village will need to decrease the number of Class D liquor licenses by one then subsequently increase the number of Class D liquor licenses by one regarding the new owner's application. There is currently a total of four Class D License issued.

All appropriate paperwork for the liquor license application has been submitted. A background check has been conducted and cleared. Staff is soliciting feedback from the Village Board on the proposed Class D Liquor Store License.

Re: Local Municipal Sales Tax Referendum

At the November 6th Village Board meeting, staff presented the preliminary 2023 tax levy estimates. As discussed at the meeting, the Village's total 2023 tax levy request will be \$2,801,000, which represents a 4.13% increase over the 2022 tax levy extension. The increase is made up of a 2.5% CPI increase and the added value of new construction.

A large part of the referendum process is disseminating information to the public so they can make informed decisions about the matter. To that end, staff will be presenting on several items and initiatives that the Village plans to utilize to share information with the public.
