



Advertisement for Bids

The Village of North Aurora will receive sealed bids for the 2024 Road Program Project. The sealed bids will be received at the North Aurora Village Hall, 25 East State Street, North Aurora, Illinois 60542 until 9:00 a.m. local time on Tuesday, April 9, 2024. At this time and date, the bids will be publicly opened and read aloud. All bids must be addressed as follows:

The proposed improvements will be completed on the following streets: Anna Street, Creekside Court, Fieldside Lane, Flagstone Court, Foxhill Court, Foxhill Lane, Greenview Court, Harmony Court, Hearthstone Lane, Hickory Street, Laurel Drive, Oak Hill Court, Parkside Court, Pinehill Court, Pinehill Drive, Prairie Court, Ridge Road, Sharon Lane, Silver Trail, White Oak Drive, and Windstone Lane.

The project will include the following pay items and quantities. Preparation of Base (55,005 SY), Hot-Mix Asphalt Surface Removal 4" (55,005 SY), Hot-Mix Asphalt Binder Course, IL-19.0, N50 (7,191 TON), Hot-Mix Asphalt Surface Course, Mix "D", N50 (5,602 TON), Combination Concrete Curb and Gutter Removal and Replacement (8,254 FT), Sidewalk Removal (20,816 SF), PCC Sidewalk 5 Inch (20,979 SF), Detectable Warnings (684 SF), Inlet Adjustments (82 EA), HMA Driveway (1,233 SY), and Restoration (2,876 SY).

The bid packet can be downloaded, free of charge, at the Village's website <http://northaurora.org/government/rfp-rfq-bidding.aspx> or can be picked up at 25 East State Street, North Aurora, IL 60542 beginning Thursday, March 21, 2024. **All bidders must be pre-qualified with the Illinois Department of Transportation to bid on this project.**

Each bid must be accompanied by a Bid Guarantee in the form of a Bid Bond from a company with an A-1 best rating, or a cashier's check in the amount of five percent (5%) of the total bid and made payable to the Village

of North Aurora, 25 East State Street, North Aurora, Illinois, 60542. The Village of North Aurora reserves the right to reject any or all bids and to waive irregularities and informalities in the bids received.

All applicable laws, ordinances, resolutions, and the rules and regulations of all authorities having jurisdiction over construction of the Project shall apply to the contract throughout including the Illinois Prevailing Wage Act (Ill. Rev. Stat. Ch. 48, Sects 39s-1-12), the Illinois Preference Act (Ill. Rev. Stat. Ch. 48, Sects. 2201-2207) and an Apprenticeship Training Program certified by the USDOL.
