The Village of North Aurora will receive sealed bids for the 2025 Road Program Project (IDOT Section #: 25-00059-00-RS). The sealed bids will be received at the North Aurora Village Hall, 25 East State Street, North Aurora, Illinois 60542 until 10:00 a.m. local time on Wednesday, April 2, 2025. At this time and date, the bids will be publicly opened and read aloud. All bids must be addressed as follows:

The proposed improvements will be completed on the following streets/locations: Aspen Court, Carlisle Lane, Deerpath Road, Elleby Avenue, Elleby Court, Hampton Avenue, Hathaway Court, Lake Run Court, Lake Run Lane, Lilac Lane, Linn Court, Mooseheart Road, Remington Lane, Western Drive, Woodland Circle, and Fox Metro Pump Station.

The project will include the following pay items and quantities. Preparation of Base (44,610 SY), Full Depth Hot-Mix Asphalt Pavement Removal 4" (40,861 SY), Hot-Mix Asphalt Binder Course, IL-19.0, N50 (6,046 TON), Hot-Mix Asphalt Surface Course, Mix "D", N50 (4,635 TON), Combination Concrete Curb and Gutter Removal and Replacement (6,121 FT), Sidewalk Removal (9,682 SF), PCC Sidewalk 5 Inch (9,581 SF), Detectable Warnings (512 SF), Inlet Adjustments (103 EA), HMA Driveway (901 SY), and Landscape Restoration (2,027 SY).

Each bid must be accompanied by a Bid Guarantee in the form of a Bid Bond from a company with an A-1 best rating, or a cashier's check in the amount of five percent (5%) of the total bid and made payable to the Village

of North Aurora, 25 East State Street, North Aurora, Illinois, 60542. The Village of North Aurora reserves the right to reject any or all bids and to waive irregularities and informalities in the bids received.

All applicable laws, ordinances, resolutions, and the rules and regulations of all authorities having jurisdiction over construction of the Project shall apply to the contract throughout including the Illinois Prevailing Wage Act (Ill. Rev. Stat. Ch. 48, Sects 39s-1-12), the Illinois Preference Act (Ill. Rev. Stat. Ch. 48, Sects. 2201-2207) and an Apprenticeship Training Program certified by the USDOL.
